You are requested to follow the instructions during the supply of basic information of students of +3 Arts/ Science/Commerce (**2023 Admission Batch**). Data relating to the subject cited above was provided by SAM's portal which has been successfully migrated to UUeMS. Like previous year the colleges need not feed the data manually or not to prepare excel sheet for UUeMS. University will provide Institutions/College wise data through uuems.in (CBCS) login along with 16 digit auto generated Registration-cum-Roll No.

Colleges are requested to update the Generic Elective subjects and correction of name (if any) of 1st and 2nd Semester for the Students of 2023 Admission Batch only during the period of form fill-up.

Before filling the forms following instruction may Please be noted:

- Colleges can't change the Honours Subjects.
- Colleges can't change Father Name, Mother name etc.
- If they want to change above information of a student they are requested to change it at SAMS portal then after obtaining approval of Controller of Examination it will be changed at UUeMS portal.
- Colleges need to deposit Examination Fees, Registration fees and other fees for all the students.
- All Autonomous colleges are requested to deposit the Registartion fees only. (As per Point No.3 Below)

You are further requested to forward the alphabetical list of students, prescribed fees and other connected documents in support of the students of your College/Institution for their 1st Semester (R & B) Examination 2023 to be held in January 2024 for +3 Arts, Science & Commerce. The examination will be conducted as per the Regulation & course structure of New Model Syllabus for 2023 A.B.(Regular) and 2019,2020,2021 & 2022 A.B.(Back) will be as per regulation of New Model syllabus.

NB : Autonomous Colleges under Utkal University are instructed to deposit the registration fees and other fees within 20.01.2024.

The voucher may be kept with the principal for audit purposes.

4. Deposit of Fees:

The fees so collected may be credited to the General Fund Account of the University in shape of consolidated Bank Draft in favour of Comptroller of Finance, Utkal University payable at State Bank of India, Utkal University Campus Branch, Vani Vihar mentioning Code No.2135. The College seal, College code, and name of the examination should be mentioned in the back side of the Draft by the concerned college. Excess amount if paid by the college, this will not be adjusted or refunded.

7. Preparation of Alphabetical List:

Different proforma, alphabetical lists already received by the Examination Assistants of all colleges previously be prepared carefully as per the instruction given to them earlier and the same hard copies may be submitted in the concerned Examination Section of the University positively. The University Registration Number of each candidate should be indicated against each of their names in the alphabetical list. All entries in the Alphabetical list be made in capital letters and the names of the candidates be carefully prepared without mistake. SC/ST/OBC/W/PH/VH candidates should be mentioned in the alphabetical list positively.

8. Documents to be submitted by the College:

- a) Recognition order of the Government.
- b) Affiliation order from Utkal University whether it is temporary or permanent.
- c) Forwarding Letters, Payment Slip (two copies).
- d) Accounts Statement (Three copies).
- e) Bank Draft (Consolidated).
- f) Payment receipt (those who are paid through online banking system)
- g) Alphabetical list
- h) Clearance Certificate of Sports Council, CDC and NSS etc.

9. IMPORTANT INSTRUCTIONS:-

The Alphabetical list and related documents will be accepted from the College between 10.30 A.M. to 4.00 P.M. on the scheduled dates.

- i) Excess number of students admitted beyond the affiliation strength will not be accepted. Similarly the statement in respect of subjects, without affiliation order will not be accepted and the same will stand cancelled automatically without further correspondence.
- The Account Statement with Bank Draft, Alphabetical List of the students and other connected documents of 2023 A. B. Regular and 2019,2020,2021 & 2022 Admission Batch Back is to be submitted in the Examination-II Section.

N.B.: (1) Recognition Order from the Government, Affiliation Orders of Utkal University (2023 Admission Batch) should be submitted at the time of submission of Alphabetical List. The receipt of the fees deposited towards Sports, CDC, NSS etc. should be submitted along with Alphabetical lists.

(2) No further extension will be made after the above mentioned dates. As per the New Model Syllabus Regulation, if a student fails to enroll in 1st Semester Examination 2023, he/she has to enroll in the 2nd Semester examination mandatorily, failing which their studentship will be automatically cancelled.
